

S-BRAA OPEN FUTURITIES
Held At The Lee Jackson Classic
August 29 & 30, 2009
OPEN FUTURITY RULES

1. Owners must be current members of ApHC in good standing. Exhibitors must be current members of ApHC in good standing.

2. ALL OWNERS AND EXHIBITORS MUST BE MEMBERS OF SBRAA BY JULY 15, 2009. PAYING YOUR SBRAA MEMBERSHIP FEE AT THE SHOW WILL NOT QUALIFY YOU.

3. The horse MUST be registered with the ApHC (show papers or PP). **EXCEPTION -WEANLINGS MAY SHOW ON ApHC BREEDER'S CERTIFICATE OR REGISTRATION PAPERS IN THE WEANLING FUTURITY (PP NOT NECESSARY TO COMPETE IN WEANLING FUTURITY).**

4. Entries MUST show proof of registration/ ApHC Breeder's Certificate by sending a copy (front & back) OF REGISTRRTION PAPERS OR BREEDER'S CERTIFICATE with final payment.

5. Postmark constitutes date of entry.

6. Horses retain all futurity rights. New Owners are responsible for informing futurity chairman of changes. PRIZE MONEY WILL BE AWARDED TO THE LAST RECORDED OWNER ON THE REGISTRATION PAPERS/APHC BREEDER'S CERTIFICATE.

7. ALL ENTRY FEES ARE NON-REFUNDABLE.

8. Payback will be mailed 14 days after the show. NO EXCEPTIONS

9. SBRAA will withhold no more than 10% of all entry fees to cover expenses.

10. Each purse will pay back to 6 places, as follows:**1st 35%, 2nd 25%, 3rd 15%, 4th 12%, 5th 8%, 6th 5%**

*****CLASSES THAT HAVE 6 OR MORE ENTRIES WILL HAVE \$500 ADDED!!!!!!!. IF LESS THAN 6 ENTRIES \$250 WILL BE ADDED!!**

11. ALL HORSES WILL BE CHARGED A \$10.00 office fee at the show.

12. ANY situation not covered by these rules will be addressed by the Board of Directors of the S-BRAA at their next scheduled meeting.

13 ANY FORGING OR ALTERING OF COGGINS OR BREEDER'S CERTIFICATES WILL BE REPORTED TO ApHC AND THE VA. DEPARTMENT OF AGRICULTURE.
